#### Funded Project Information: Glossary of Terms

Sustainable Development Technology Canada (SDTC) is a foundation created by the Government of Canada to support Canadian companies with the potential to become world leaders in their efforts to develop and demonstrate new environmental technologies that address climate change, clean air, clean water and clean soil.

The Funded Project Information displays project level details for SDTC's funded portfolio since inception. The information is updated monthly and includes an **Active Projects** sheet and an **Inactive Projects** sheet.

**Active Projects** include non-contracted and contracted projects, as well as projects that are completed or terminated but have not yet completed all project reporting.

**Inactive Projects** include completed, terminated and cancelled projects.

The following details are included in the Funded Project information:

Funded Company – The company receiving funding from SDTC to carry out an approved project.

Date Approved – The date that the project was approved by SDTC's Board of Directors.

**Date Announced** – The date that the project approval was announced.

**Date of Completion** – The date that the project was completed (for Inactive projects only).

**Economic Sector** – The economic sector of the approved project.

**SDTC Contribution** – The amount of SDTC funding allocated to a project. For Active Projects, the value at the time of announcement is provided and for Inactive Projects, the value at announcement and at project completion is provided.

**Funded Company Contribution** – The amount of funding the funded company is contributing to the project. For Active Projects, the value at the time of announcement is provided and for Inactive Projects, the value at announcement and at project completion is provided.

**Government Funding** – The total government funding, including municipal, provincial and federal funding for the project. For Active Projects, the value at the time of announcement is provided and for Inactive Projects, the value at announcement and at project completion is provided.

**Eligible Project Cost** – Costs required to complete the project that are eligible for SDTC contribution. For Active Projects, the value at the time of announcement is provided and for Inactive Projects, the value at announcement and at project completion is provided.

**City** – The city where the funded company is headquartered.

**Province** – Displays the province the funded company is headquartered.

**Postal Code** – The postal code of the funded company's headquarters.

**Key Products/Services** – The funded company's key products and services.

**Company Description** – A description of the funded company.

**Project Title** – The title of the approved project.

**Project Description** – A description of the approved project, including an overview of the technology and the objective of the project.

Consortium Members -A list of the consortium members participating in the project.

**Fund** – The fund the project is receiving funding from: the SD Tech Fund or the Next Generation Biofuels Fund (NGBF). For more information on SDTC Funds: https://www.sdtc.ca/en/apply/funds/

**Climate Change** – Indicates if a project has potential environmental benefits related to climate change.

Clean Air – Indicates if a project has potential environmental benefits related to clean air.

Clean Water – Indicates if a project has potential environmental benefits related to clean water.

Clean Soil – Indicates if a project has potential environmental benefits related to clean soil.

**Results** – Describes the project outcomes, for completed projects.
